ROLL CALL AND DECLARATION OF A QUORUM

APPROVAL OF MINUTES

EQUIPMENT PURCHASE UPDATE/SNOW REMOVAL UPDATE

Mike Wood advised the board that the snowplow purchased this winter was able to handle the 6" snow we got and no other city plows were needed. Also purchased was a "Buffalo Turbine" blower for debris removal. We received it in March and it clears the runway/taxiways well.

PENDING END OF RUNWAY WORK

The board was notified of the upcoming End of Runway work to commence on 4/9/25. Work will start on the north end and will not affect airfield operations other than the airfield lighting will not be operational intermittently during daylight hours only. Completion date has yet to be determined but is expected in the next 60 days
