FINANCE REPORT

February 2026 Financials

Park Director John Shelton reported on the financials and explained that some line items are being consolidated. As a result, certain categories, such as utilities, may no longer show individual budgeted amounts as they have been combined into a general account. He noted that, overall, the budget remains in very good shape.

## DISCUSSIONS AND PRESENTATIONS

### Atchley Park Construction Update

Park Director John Shelton reported that construction of the restroom and concession stand is on schedule. He stated that concrete is planned to be poured next week for the bleacher pads and covers. He also noted that the pickleball courts were being painted, with a goal of completing the painting by Saturday, March 14th, and that fencing is expected to be installed within the next few weeks. Additionally, he shared that the project is currently waiting on adapters for the light poles, after which the lights will be ready for installation.

### Baseball/Softball Sign-Ups

Assistant Park Director Elliot Willburn reported that 20 teams have entered the spring competitive league, an increase from 15 teams last year. He noted that the league will begin on March 31. He also shared that registration for the recreational summer league is currently open through March 22, with games set to begin on May 18. Additionally, he stated that the first weekend tournament is scheduled for March 22.

### Seasonal Hiring

Park Director John Shelton reported that job postings are currently open for seasonal positions. The openings include 2 maintenance positions, 6 concession positions, and 4 lifeguard positions. He noted that the pool manager and both Lifeguard II positions from last season will be returning.
